RE: FINAL NOTICE OF FORMAL DEMAND FOR PAYMENT OF INDEBTEDNESS (\$20,000.00 USD)

PLEASE TAKE NOTICE that this letter constitutes formal legal demand. You remain indebted in the total principal sum of \$20,000.00 (Twenty Thousand and 00/100 US Dollars) arising from the following transactions:

- **1. June 14, 2021 — \$10,000.00 USD:** Bank of America Online Transfer to Katruzov (Acct *9652, Conf # HDM0QUN80).
- **2. June 16, 2021 — \$10,000.00 USD:** Bank of America Official Cashier Check deposited to Katruzov (Acct *9652, Conf # RN62J-12S02).

These funds were provided under the express representation of securing commercial trucks for Space Truck Inc (Kenworth order #TRCK-SALE-WI-4.3-02-A). Despite acknowledging this obligation, you have failed and refused to repay these funds while acquiring residential property (\$433,300.00) and commercial assets.

DEMAND FOR IMMEDIATE SATISFACTION

DEMAND IS HEREBY MADE that you pay the full amount of \$20,000.00 within FOURTEEN (14) CALENDAR DAYS from the date of this notice.

NOTICE OF FORTHCOMING LEGAL PROCEEDINGS

If full payment is not received within 14 days, civil litigation will be commenced in the County Court of Flagler County, Florida, seeking: (1) Full principal of \$20,000.00; (2) Statutory pre-judgment and post-judgment interest (F.S. § 55.03); (3) Court costs; (4) Post-judgment garnishment of commercial operating accounts (Take Truck Inc / Space Truck Inc) and real property attachment.
